

Invitation to Tender for the Litter Collecting Contract – Litter Collecting in the Parish of Portreath. For the period 1st April 2023 to 31st March 2026

Portreath Parish Council are inviting tenders for the contract for Litter Collecting in the Parish of Portreath.

Requirements

May – September

Weekly: Collect litter throughout the parish. Dispose of all litter at an approved location. The area for collection of litter will include, all roads within the centre of the Village of Portreath, including the pedestrianised areas known as Chynance and Forth an Nance and Tregea Hill. The entirety of Lighthouse Hill to the gates of RRH Portreath. The area of the Small Beach in front of the properties known as Chynance, up to and including under the steps of the Sea Wall. The New Portreath Road (B3300) from Portreath Village to the parish boundary at Cambrose (Junction with Chapel Hill). The Road from the parish Boundary at Cambrose (Bridge on the B3300), through Cambrose, Nancekuke and to the parish boundary at Rose Hill. Bridge Hill from the B3300 to the Parish Boundary.

October – April

Monthly: Collect litter throughout the parish. Dispose of all litter at an approved location. The area for collection of litter will include, all roads within the centre of the Village of Portreath, including the pedestrianised areas known as Chynance and Forth an Nance and Tregea Hill. The entirety of Lighthouse Hill to the gates of RRH Portreath. The area of the Small Beach in front of the properties known as Chynance, up to and including under the steps of the Sea Wall. The New Portreath Road (B3300) from Portreath Village to the parish boundary at Cambrose (Junction with Chapel Hill). The Road from the parish Boundary at Cambrose (Bridge on the B3300), through Cambrose, Nancekuke and to the parish boundary at Rose Hill. Bridge Hill from the B3300 to the Parish Boundary.

Contractor Responsibilities:

- Contractors will provide all their own equipment.
- Contractors will be responsible for providing their own transport, and the transport of all litter collected.
- Contractors will be responsible to dispose of all litter in a lawful manner.
- Contractors will hold the relevant Certificate of Registration under the Waste (England and Wales) Regulations, and when supply a copy of the appropriate certificate including the registration number to the Clerk to the Council.
- Contractors will have full public liability insurance, a health & safety policy and appropriate risk assessments in line with The Health & Safety at Work act 1974

The Contract will run from 1st April 2023 to 31st March 2026. The rates agreed at commencement of contract will increase annually in line with the government official RPI as quoted for March at the end of each contract year. (Ordinarily published in April). The increase will be subject to a satisfactory review of services in the preceding year.

Opportunity tender for works form 1st April 2026 will be advertised in autumn 2025.
